## The CCN-RFO study

- Conducted in collaboration with our Country Correspondent Network (CCN) and International Satellite Partners (ISP)
- An open Research Protocol and two online training sessions
- CCs and ISPs collected policy and Funding Call documents
- Conducted one interview with an official from each RFO
- Wrote a Case Report following a template
- Quality assurance was managed through cross-reading and review in regional groupings



## Study objectives

- Understand the role of RFOs in supporting and enhancing responsibility in R&I cultures and practices
- Research question

How do RFOs exert responsibility pressure?

- Through three mechanisms
  - Priority setting
  - Funding instruments
  - Research and researcher assessment
- How are societal stakeholders involved?




## Participants

50 European RFOs (/52) 3 International






## Policies

- Aspirations expressed in interviews






## Advice



- Mainly required or preferred approaches or actions




# Repertoire – responsible assessment processes

Criteria for selection of reviewers

Training or guidance provided

Composition of assessment panels

- Avoidance of unconscious biases.
- Mitigation of gender bias
- Achievements assessed relative to opportunities
- Treatment of career breaks or changes
- Valuing inter/transdisciplinary approaches



- Number / type of elements
- Inclusion of societal stakeholders
- Training / guidance provided





## Summary

- Research funders typically have multiple responsibility-related policies, many are included in broader policies or strategies
- Societal stakeholders are present in a large majority of RFO's formal advisory bodies – and strongly represented in around half
- Data analysed to date shows that RFOs exert considerable responsibility pressure through funding instruments and in the conduct of research/er assessments
- A diverse repertoire of responsible approaches to assessment is evident, with opportunities for further learning and take-up
